



**1. Opening of the Meeting**

The Chairman, Mika Kojonkoski (FIN) opens meeting on Wednesday, 8.05.2024, 13.00 hrs at the Bernarding hotel in Portoroz (SLO).

Chairman welcomes members of the Jumping Committee, Chairmen of sub-committees, FIS staff, athletes' representatives, co-partners, stakeholders, and guests.

He informs that only members are allowed to speak, others are required to communicate with their respective NSA representatives.

Chairman thanks chairmen of sub-committees FIS staff for preparation of the sub-committees and jumping committee preparations.

Chairman thanks FIS staff for successful winter season implementation

- 40 WSC and WC Men competitions and only one replacement despite challenging weather and snow conditions
- 18 nations with WC points, 21 athletes from 7 nations on the WC podium
- almost 30 WC Women competitions with cancellation in Zao, Rasnov (3x) and Vikersund
- 16 nations with WC points, 13 athletes from 8 nations on the WC podium
- first ever SF WC event with new world record

Media interest and TV figures of our sport are rising thanks to involvement and work of our NSA and LOC.

In the course of the meeting, **FIS President Johan Eliash** visits with some words to the members of the Jumping Committee.

He comments of the centralisation of FIS TV and marketings rights, as well importance of digital media in the production and promotion of FIS events. He emphasises the importance of conquering new markets and becoming even more global. The undertaken changes are not always easy but in the long run will enable FIS to take full control over the events.

## **Ski Flying Competitions**

### **The Number of Days and Jumps**

Ski Flying events will take place over four days. If any of the rounds must be cancelled and repeated, no more than ~~four~~ **five** official flights per day per jumper are allowed. This rule also applies to forerunners.

### **World Cup Men rules**

#### **4. WCJ-Competitions**

##### **4.1 Number of Participants for the National Ski Associations**

The number of participants will be calculated periodically according to:

- the World Ranking List (see art.4.1.1)
- the standings of the actual Continental Cup-Men period
- **result of the individual competition in the JWSC (top-3 athletes only)**

The basis for the calculation is:

- the top 45 competitors in the World Cup Allocation List (see art. 4.1.2) that is based on the World Ranking List (with a maximum of 5 athletes per nation)
- the top three (3) of the COCJ-M period
- **the best 3 athletes of the Individual competition at the JWSC (with a maximum of 1 quota per NSA; by nation, not nominative); quota valid for the entire period after the JWSC until the week before the following JWSC; respective NSA is allowed to use the quota for another athlete fulfilling the age criteria of the respective JWSC**
- However, quota is limited to a maximum of ~~6~~ **7** athletes per nation.
- Apart from the nations' quota (according to the ranking list), each nation which has gained at least one (1) individual- or team competition point during the past or the current competition season shall have a basic quota of **two athletes one plus two (1+2) for at least 2 x 7 periods. This is therefore also valid for points obtained from the GP.**

##### **4.1.3. Starting quota in the official training**

Each National Ski Association is allowed to enter the number of athletes according to their nations quota, but no more than six (~~7~~ **6**) as a maximum.

The maximum starting quota of the National Ski Association of the organizing country is therefore **11** ~~10~~ athletes for the official training and the qualification round, and all other participating nations may enter up to a maximum quota of **seven** ~~six~~ (~~7~~ **6**) athletes.

##### **6.1 Nations' Quota for the Reimbursement of Expenses**

The national quota for the participating nations will be determined as follows:

A World Cup Allocation List will be established using the results from the Summer Grand-Prix and WCJ competitions (art. 4.1).

From this World Ranking List will be included at the end of each of the 7 periods:

- the top 45 competitors in the World Cup Allocation List (with a maximum of 5 athletes per nation)
- the top three (3) athletes of the current COCJ-M period,
- **additional quota from JWSC (art. 4.1) are not entitled to any travel and accommodation reimbursement**
- **as well as a basic quota that consists of one athlete plus two coaches (1+2) for at least 2 x 7 periods. This is therefore also valid for points obtained from the GP.**
- Each National Ski Association has the right to be reimbursed for a maximum of six (6) athletes.
- The number of officials that have to be covered will be determined according to the following standards:

The organizer has to provide and take over a shuttle service between the accommodation and the competition site.

#### 4. Competition Mode and Starting Order

##### 4.6 KO-System

The Jumping Committee is entitled to modify the abovementioned rules for the qualification and competition rounds.

Competition format for Two Nights Tour 2024/25

The qualification round would reduce the field to 30 athletes.

In the first competition round athletes are jumping with the K.O. system.

After the duels, 15 winners and 5 "lucky losers" will continue to the final round.

#### 4.9. World Cup Ski Flying Women

The WCJ-events in Ski Flying must be carried out according to the World Cup rules for Ski Jumping as well as according to ICR art. 454.

For World Cup Ski Flying, the ~~15~~ 25 ranked competitors of the current World Cup overall standings ~~and a maximum of five competitors who receive the starting right,~~ are allowed to start for first competition round. After the first round, only best 15 athletes are qualified for the final round.

Athlete must have eighteenth date of birth by the first official training day.

~~Maximum five athletes who are top 15 of Raw Air standing after WC on Trondheim on March 13 (Wednesday) 2024.~~

~~The definition of criteria for additional right to start will be confirmed and announced at the autumn jumping committee at the latest.~~

Starting order for official training will be used according to the WC standing in reverse order. Comment from Race Director Chika Yoshida – average of all jumps from official training with judges' scores will be taken to establish starting order to the competition.

National Ski Association has informed the OC of the members of the team, arrival day, arrival time and the flight number.  
The organizer has to provide and take over a shuttle service between the accommodation and the competition site.

#### **Specification of Competition Equipment**

##### **4.5 Suit marking**

All suits used in FIS series must be marked with FIS designated system prior to events. A set of numbered, encoded chips will be dedicated to each suit and the data regarding the name of the athlete and the suit numbered will be recorded in a designated FIS system. Each part of the suit will be marked with a chip after being inspected by the controller. It is not allowed to replace any parts of the suit after they have been inspected and marked. Athletes are not allowed to remove or manipulate with the markings.

#### **GUIDELINES**

##### **SUIT MARKING / SUIT EXCHANGE test phase summer 2024**

Summer 2024

4 suits per jumper per summer season

2 suits per event  
1 suit per competition

In case qualification and competition are carried out the same day – 1 suit is allowed for qualification and 1 for competition

Suit exchange is case of damaged suit

- Rainy weather – in case of rain the equipment controller decides if the second suit of the event is allowed in competition
- Suit damaged outside of competition – no change
- Suit damaged in the course of the event – in competition, the suit must be presented to the controller for the inspection
- In case of a suit damaged in competition, a damaged part can be replaced after the inspection and approval by the controller
- Inspections before the jump, not after the jump
- Tested at the start before the jump  
(torn seams must be fixed!!!)

#### 4.3 Underwear

Ski jumping underwear shall be made of elastane type of fabric which is a combination of polyester and polyurethane (Lycra, Spandex, etc.). The underwear shall consist of two parts (shirt and pants). The arm sleeve must end before the elbow. The leg of the pants must end before the knee. Overlapping of the stockings/socks and the pants is not allowed. All portions of the ski jumping underwear must be made of the same material and must show the same air permeability from the outside in and from the inside out. Outer tucks and darts, folds and padding are not allowed. The thickness of all parts of the underwear must be the same and must not exceed 1.5 mm. Cumulative thickness at seams, all layers and parts of the underwear together must not exceed 3 mm. All hems must be sewn by a singular piece and the entire piece must have the same physical material characteristics. Seams may only exist in order to join the portions of the underwear. All seams must be straight or formed differently only to fit the form of the body. Any additional seams or transformation of the seams, any strings, rods, folds, tapes, etc., inside or outside the underwear are not allowed. Only one layer of fabric is allowed over the whole area of both underwear pieces. The fabric must have an even and regular surface, free from perceptible projections, lumps or indentations.

The cut of both parts of the underwear must be made according to the below drawings: **drawings to be sent out at a later stage.**

Air permeability of the underwear must exceed 60 l/m<sup>2</sup>. The size, fit and form of underwear must conform the size and shape of the body. No zipper, buttons, Velcro or similar on the T-shirt are allowed. It is not allowed to attach or fix the underwear to any part of the body or the suit (straps, hooks, tapes, or other fixing or helping material, etc.). No fixations (i.e. integrated holes for fingers) are allowed. **No silicon lining/taping of any kind is allowed. A rubber band around waist of the shorts seam of 3 max cm width is allowed.** No form of a hood is allowed.

### **Crotch control**

Crotch control can take place before and/or after jump.

### **START CONTROL**

Crotch control at start begins at the virtual line.

Athlete prepares for crotch control before designated virtual line.

Stretching and manipulating of the suit is not allowed.

Athletes walks to the control box in a natural, relaxed body position, the suit cannot be fixed in any way in any part of the suit/body.

When the control is taken, the suit must be body fitting in all parts.

Athletes must follow the instructions of the equipment controller, otherwise control might be refused (NPS – ICR 441.5 or ICR 441).

### **4. Ski Jumping Suit**

Only one fixed (non-adjustable) strap per leg is allowed for fixing the suit around the ski boot.

The strap is of one continuous piece and without clips, buckles or other means of fastening multiple pieces of material.

The fixation of either strap must be made at the hem of the suit in the middle of the posterior and anterior seam of the leg panels (see the illustration - mark S).

Leg hem must be cut horizontally straight across the width of the strap at the same height.

The leg hem must not exceed in length the lower sole of the ski jumping boot.

The width of the strap must be min 2 and max 4 cm.

The width of this part of the leg must not exceed respective strap width.

The strap must be placed at 90 degrees angle to the boot sole and in line with the leg panel seams.

The leg of the suit cannot be fixed to the boot in any other way than with the strap **and must end above the strap in a way that the strap is not covered along its full length.**

**Number of parts of the material of which the suit consists of is:**

Crotch At the height of 2 cm, the front seam must protrude **maximum** 3 cm to the front from the intersection of the crotch seams, while back seam must protrude **maximum** 5 cm to the back from the intersection of the crotch seams according to the below template, while the suit is placed inside out. Intersection of the crotch seams must always be the lowest part. The seams from the intersection at crotch towards the waist seam must go with one single curve and straight.

**„The seam from the end of the zipper in front, along the crotch area, to the waist seam in the back must be the main/leading seam, and needs to be sewn in one line. The inner leg seams must be connected to this main seam.“**

- For all FIS event applications, the National Ski Association must submit a written guarantee that the event organiser will have a current and valid Jumping Hill certificate if one is required in the event season.

- In addition, a written guarantee is also required from the respective National Ski Association that the event organiser will also undertake all the hill modification requirements for the specific hill as set forth by the FIS Sub-Committee for Jumping Hills



and according to the season analysis 2018/19 of the Sub-Committee for Calendar planning (see minutes of the meeting of 12 th April 2019).

- Additional review points to be evaluated for World Cup calendar applications will include the: COC and FIS Cup event applications for Ski Jumping received by the respective National Ski Association's applicant in addition to the World Cup event application
