Minutes of the Meeting Sub-Committee for Classification of Alpine Competitors Monday, 06.05.2024, 11:00 – 13:00hrs

1. Welcome (Jeff Weinman, USA)

The Chairman Jeff Weinman (USA) welcomed the members and guests and thanked them for their participation.

2. Roll Call (Janez Flere, FIS)

Janez Flere (FIS) called the roll of members present and replacements and stated that only named members present are eligible to vote.

3. Approval of the agenda (Jeff Weinman, USA) The agenda was approved without objection.

4. Approval of the minutes of the meeting held 27.09.2023 in Zurich (SUI) The minutes of the meeting held in Zurich (SUI) were approved without objection.

5. Reports

5.1 Jeff Weinman, Chairman

The Chairman thanked the FIS Office for all the work on behalf of the members and National Ski Associations.

He reviewed a 9-year history of race data – that information is included at the end of these minutes. The current data show positive trends for our sport.

5.2 Daniel Défago, FIS Office

Daniel Défago (FIS) reported that the qualification period for the OWG 2026 in Italy begin 1st July 2024 and the Qualification System document is available on the FIS Website.

Electronic board/draw allowed for the FIS level. This feature uses the same technology as the live timing.

5.3 Janez Flere, FIS Office

Janez Flere (FIS) noted that only races where there are 20 women or 30 men in the finish will be valid for OWG selection to help combat manipulation.

There was recently a race in Italy where the Jury decided not to make it valid for FIS points due to manipulation of the course prior to the top two athletes taking their second run. Weinman (USA) praised the TD and Jury for taking action and the affected athletes for making the Jury aware.

6. Proposals

6.1 Art. 7.6.3 Deadline for Special quotas (USA)

Weinman explained that the proposed language was to bring our rules in line with our current procedures which have followed the past few years since Covid. While the deadline is 10-days prior to the first team captains meeting to have all approvals, the sooner that approvals can be made the better.

7.6.3 Special Quotas

The FIS <u>Council Alpine Committee</u> can allow special quotas for certain countries and regions. National Ski Associations <u>concerned</u> must <u>provide</u> <u>send</u> <u>direct</u> specific <u>event</u> requests <u>and approval</u> to the FIS <u>Sub-Committee for Classification</u> <u>of Alpine Competitors</u> a minimum <u>of 10 days</u> two weeks before the <u>first Team</u> <u>Captains' autumn meeting</u>. For the Southern Hemisphere: two weeks before the spring meeting.

The proposal was approved without opposition.

6.2 Minimum penalty for NC (GER-SUI)

Germany made the decision to pull this proposal from consideration.

6.3 Minimum penalty Citizen events (FRA)

The Sub-Committee for Alpine Citizen Races proposed two changes that impact the points list and so were submitted for review.

1. Minimum penalty for CIT: 23 (level 3)

1 Move Race CIT at new level: Penalty minimum: 40 - maximum 999.

The proposal to change the minimum penalty for CIT races from 23 to 40 was approved without objection.

2. Art CIT 1.1 1. QUALIFICATION OF ALPINE CIT COMPETITORS Définition: In order to start in a citizen competition, the athlete must have more than 30.00 FIS points in the event concern (GS: 30.00 - SL: 30.00) and 25.00 FIS points in speed events (DH: 25.00 - SG: 25.00 - AC: 25.00). 2 Cancel Art 1.1 (CIT Rules)

The proposal to delete Art. CIT 1.1 was not approved.

6.4 FIS Points list Deadline Art 5.3

The list schedule was presented without objection.

7. Precisions

7.1 Art. 4.6 Injury Status (USA)

The Chairman stated that the precisions to the injury status regulations were to remove confusion on how they are used. There is no changed to the intent or implementation of the rule, only to how it is presented.

Precisions Wording Injury Status Rules

- 4.2.1.4 If the status as injured is approved <u>according to 4.6.1.1, then</u>, and competitors have not started more than five (5) times (FIS and COC level competitions) plus four (4) times (World Cup competitions) in one event and/or more than fifteen (15) times (FIS and COC level competitions) plus eight (8) times (World Cup competitions) across all events during the valid season 10% (#) will be added to the competitor's BL if the current points are not better than the protected points.
- 4.6 Injury Status
- 4.6.1 Registration

When a competitor gets injured and applies for the single penalty, the National Ski Association must apply to the FIS as soon as possible or <u>at the</u> latest 30th April for the approval using the official online system (Injury Database). The medical certificate must report in detail the kind of injury and the period of recovery. This official form and medical certificate are only valid for one season. (World Cup: see World Cup Rules art. 22.2)

4.6.1.1 Conditions for Injury Status

- At least 8 months must have been passed between the time of the injury and the competitors 1st start.

- Competitors must remain registered as active with the FIS to maintain injury protection.

- Competitors who exceed any one or more of the following start limitations are not eligible for injury protection

- <u>Have started more than five (5) times in at least one event in</u> Level 1, 2, 3, or 4 competitions

- <u>Have started more than four (4) times in at least one</u> event in Level 0 competitions

<u>Have started more than fifteen (15) times in all events in Level</u> <u>1, 2, 3, or 4 competitions</u>

- Have started more than eight (8) times in all events in Level 0 competitions

- Injury protection is all or nothing such that a competitor either gualifies, or does not, for all events based upon the above conditions.

- <u>At least eight (8) months must have passed between the time</u> of the injury and the competitor's first start.

- If a competitor starts before the eight (8) month period, their BL points will be recalculated to reflect their points without injury status.

- Competitors have not started more than five (5) times (FIS and COC level competitions) + four (4) times (World Cup, Olympic Winter Games and World Championships competitions) in one event and/or more than fifteen (15) times (FIS and COC level competitions) + eight (8) times (World Cup, Olympic Winter Games and World Championships competitions) across all events during the valid season.

4.6.2 Pregnancy

The protection status starts as soon as the medical certificate is received and confirmed by FIS (or after <u>the competitor's her</u> last start) until the birth of the child. The expected date of birth of the child must be written in the medical certificate. After the birth of the child the protection status is <u>still</u>-valid for a maximum of <u>nine (9)</u> (nine) months. Then it The protection status expires if the National Ski Association does not apply in writing to FIS for prolongation of the FIS point's protection status mentioning the exact medical reason. The procedure will be handled according art. 4.6.1.

4.7 Professional Obligations or Military Service

If a National Ski Association submits, in advance, an application for a "study or military status" certifying that a racer will not be able to compete due to professional obligations (studies) or military service and has indicated why and how long the competitor <u>will be was</u> prevented from racing, the procedure will be handled according art. 4.6.

7.2 Art. 4.8 Evaluation of Several Races (USA)

The Chairman stated that he had made an error in the language of the proposal and pulled it from consideration.

8. FIS Points rules 2024/2025

The updated FIS Points rules will be available on the FIS website after approval by the FIS Council.

9. Miscellaneous

Rules for discussions

There was discussion on potential changes in the future with a request for the National Ski Associations to think about these:

- Art 4.2 Average of three results Providing a better measure of performance than the current average of best two. The idea is that this would only be for technical races and not for speed.
- Category Adder (GER)
- To reintroduce category adders for Level 1 races.
- Minimum COC penalty (GER) To change the minimum COC penalty.



Weinman thanked everyone again for their attendance and participation.


