5. Report Alpine Women's World Cup - World Cup Team

Peter Gerdol, Chief Race Director

- 23-24 season was quite difficult in many different ways.
- 6 races lost due to weather conditions: too much snow, not enough snow, too warm, very challenging weather conditions.
- Too many injuries, 18 total, only three were able to return to competition.
- Injuries were not any specific reason, not an obvious trend.
- Fluor testing proved successful, one DSQ at first race, mistake by serviceman, set tone for rest of season with no further disqualifications.
- Communication to athletes working well
- Planning for 24-25 season
 - Inspections coming up
 - Total number of WC events reduced due to WSC
 - Only one speed event per weekend
 - Replacement for cancellation will not be made immediately rather very deliberate with space made in calendar during March.
 - Floro test same as 23-24 season plus EC testing.

Markus Mayr, Race Director, Technical Events Women

High level events, issues were weather related and not ROC issues

Alberto Senigagliesi, Race Director Speed Women

- High level and successful races
- Too many injuries, but not one specific reason
- Will continue incorporating more jumps
- Goal will always put safety first



Andres Kronner, Race Operations, Women

- Experienced large crowds, in general successful season
- Refined and efficient finish awards for television
- Press conferences only at finals
- Balancing evening programme to accommodate athletes, sponsors, and ROC in 24-25 season

Jordi Pujol, COC and EC Women's Coordinator

- Good season, opportunity to use same sites as WC
- EC finals television issue of only showing men was due to a logistical issue

6. Presentation of FIS Project Digital Gates Measurement Project

- Markus Mayr made Introduction of Mr. Martin Benk, CEO of MBCD
- The MBCD Project has gathered data from WC and EC courses over the past three years
- Project uses cutting-edge GNSS satellite technology and IT software
- Project gathers and analyses data from course setting, terrain profile and exact gate positions
- Information is available and has served as an important tool for the race directors and will eventually be available to team captain's and athletes

7. Other Alpine Committees

- Youth and Children USA proposed limiting tech event starts for first-year FIS to 30 and second-year FIS to 40 excluding OWG and WSC, passed in Y/C committee and Alpine Executive
- Alpine Rules 601.4.1.4 The Jury (OWG and WSC) of a women race composition must include at least one woman person of a different gender.
 601.4.2.3 For international races, for women the Jury composition should where possible include a women one person of a different gender.
- Much discussion followed to change "should" to "must". Further study is needed to understand the implications, but the Women's sub-committee strongly favors international juries must include one person of a different gender.
- Alpine Courses no major proposals
- All other alpine committees meet later in the week.

8. Miscellaneous

- Robust discussion on gender equity not only in juries (as above) but in committee appointments, officials, coaches etc. Are FIS member national associations meeting the gender equity goals?
- Final Note this will be my last meeting as a committee member and chair of the Women's Alpine Sub-Committee. I still have a passion for alpine ski racing and will continue to follow all things "alpine".
- A special thank you to all of you who have attended the meetings, made an
 effort to contribute and posed critical questions and concerns for women's
 alpine ski racing.
- Gratitude to the FIS staff and the Race Directors for your willingness to communicate and elevate women's WC ski racing.
