PROCEEDING OF THE MINUTES

ITEM 1 OPENING OF THE CONGRESS

President Eliasch opened the 55th International Ski Congress on 5th June 2024 and welcomed all Congress delegates Council Members and those joining online via the live stream on the FIS TV App or the FIS You Tube Channel.

Opening Speech by FIS President Johan Eliasch

Dear Ski and Snowboard friends,

I'm happy to welcome you to this 55th International Ski Congress.

It's always a pleasure to see all of you in person, even more so when we meet in a beautiful place like Reykjavik.

Thank you to our Icelandic friends for being our hosts in this special year when FIS celebrates its 100th anniversary.

The Congress is not only the highest authority in ski and snowboard: it is a symbol of how far we've come. Of how snow sports are ever more global and how our decision-making bodies reflect this.

This is a democratic forum to look after the welfare of the entire ski and snowboard community, around the whole world.

I am proud to open this Congress.

But before we move on to the many important discussions and decisions of today, I would like to invite you to take a moment to honor the members of the ski and snowboard community that have sadly left us over the last 12 months.

To their memory, a moment of silence.

Thank you for showing your respect.

Let's start the activities with some housekeeping information, as well as an introduction to legal matters and voting procedure.

Following the welcome speech by President Eliasch, FIS Secretary General Michel Vion provided a housekeeping update including the voting procedures.

Dr. Stephan Netzle provided a full legal briefing on voting and general Congress procedures in accordance with the FIS Statutes.

The <u>Congress acknowledged</u> the opening speech from FIS President Eliasch as well as the housekeeping and legal information.

President Eliasch informed the FIS Congress that the delegates from the National Ski Associations from Algeria, Belgium, India, Democratic People's Republic of Korea, Mongolia and Pakistan have not been able to travel to Iceland personally and therefore have submitted a request to take part in the Congress remotely.

The <u>Congress approved</u> the online participation of the above mentioned National Ski Association's delegates.

ITEM 7 CONGRESS PROPOSALS 2023 – FOLLOW-UP

President Eliasch mentioned the three proposals that were submitted to the Congress 2023 which had follow-up tasks.

7.1 : A proposal submitted by Austria, Germany, and Switzerland regarding the hosts of FIS World Championships: that some basic parameters are clearly established in the run-up to a possible candidature.

For example, that hosting contracts should specify the exact amount to be provided by FIS to the respective member association as organizer.

This was <u>taken into account</u> in the agreements with the hosts that were appointed by the FIS Council on 4th June 2024.

7.2: A proposal brought forward by Austria regarding the Advertising Rules and financial opportunities for National Federations and/or organizers:

FIS has <u>agreed</u> to review the matter from time to time and find practical solutions.

7.3: A proposal brought forward by Austria, France, and Switzerland related to the FIS reserves.

FIS <u>deemed</u> that reserves are not representative of FIS's ability to make distributions or provide financial support.

Art. 2 Name and Authority

The changes were originally proposed by the FIS Council which suggested some amendments to the text of the Congress Book (marked in bold).

2.4 FIS may manage Para **Snow Sports** Disciplines governed by other International Federations with which FIS has a written mandate to do so.

The <u>Congress approved</u> the proposal.

Nicolas Hale-Woods, CEO of the Freeride World Tour gave a short speech before the vote on the proposal for Art. 2.2.10

Before voting it was qualified by the President that the necessary ICR changes will be done in the ordinary course and approved by the Council. The proposal 9.4 regarding the ICR Rules on Integration of Freeride as a FIS discipline was withdrawn (see page 20).

2.2.10 <u>Freeride</u>

The <u>Congress approved</u> the proposal to include Freeride as FIS discipline.

Art. 6 Objectives

6.1.20 to strictly adhere to accepted principles of good governance in general, included but not limited to the principles of Transparency, Integrity, Democracy, Sports Development and Solidarity and Control Mechanisms, and to foster a culture of open discussion in all Governing Bodies and Committees of FIS; and

The <u>Congress approved</u> the proposal.

Art. 8.6 Honorary Membership

8.6.2 The conditions for awarding Honorary Membership or distinctions are set out in the FIS Council and Executive Committee Rules by the Council in a separate Regulation. The <u>Congress approved</u> the proposal.

Art. 10.2 Authority and Organisation of the Congress

The proposal submitted by the National Ski Associations of Austria, Denmark, Finland, Germany, Norway, Sweden and Switzerland (as shown in the Congress Book regarding agenda item 8.1.8 "Budget Process" on page 28) has been amended in comparison to the original proposal in the Congress book (marked in bold).

10.2.1.3 to review and <u>confirm</u> the annual budget. <u>For this purpose, the budget shall</u> <u>be uploaded to the FIS website 21 days before the Ordinary Congress</u>.

The <u>Congress approved</u> the proposal without discussion.

Art. 10.5 Directing the Congress

10.5.1 The President shall direct and manage the deliberations, the elections and the voting at each form of Congress. The President shall be entitled to participate in the discussions and to submit proposals during each form of Congress which, for the avoidance of doubt, are only to be dealt within the Congress if the Congress has decided that such proposals are urgent within the meaning of article 10.6.5.

The <u>Congress approved</u> the proposal without discussion.

Art. 10.10 Election of the President and the Council

The proposal submitted by the FIS Council (as shown in the Congress Book regarding agenda item 8.2.7 "Election of the President" in page 38) had been amended to the version published in the Congress Book (marked in bold)

10.10.2.2 The President shall be elected by open voting, unless the Congress, at the request of a Delegate or a Council Member, decides by a majority of all votes cast that the voting shall be by open voting, unless the Congress, at the request of a Delegate or a Council Member, decides by a majority of all votes cast that the voting shall be by secret Ballot.

The <u>Congress approved</u> the proposal without discussion.

Art. 10.6 Proposals

10.6.6 Proposals of Member Associations for modification of proposals listed and specified in the agenda of an Ordinary Congress or an Extraordinary Congress are not subject to the time limit specified in article 10.6.2 but shall be submitted to the Secretary General as soon as possible after receipt of the Congress proposals and the agenda and not later than fourteen (14) days before an Ordinary Congress or an Extraordinary Congress. Subsequently, such proposals of Member Associations for modification of proposals listed and specified in the agenda of an Ordinary Congress or an Extraordinary Congress.

The <u>Congress approved</u> the proposal without discussion.

Art. 15.2.2 The Finance Committee

The original proposal as published in the Congress book (regarding agenda item 8.1.1 "Budget Process" on page 28) had been amended by Austria, Denmark, Finland, Germany, Norway, Sweden and Switzerland (marked in bold)

15.2.2.1 a) review<u>receive</u> review the budget proposal<u>review and discuss it with the</u> person responsible for financial matters within FIS and <u>present</u> it with its recommendations recommend that it is submitted to the Congress Council for approval_Once approved by the Council, the Treasurer presents the proposal for the annual budget to the Congress in writing including comprehensive documentation and no later than one (1) month before the opening of the Congress for approval; and. Once approved by the Council, the annual budget will be distributed in <u>writing to the Member Associations no later</u> than 21 (twenty-one) days before the Congress; and

The <u>Congress approved</u> the proposal without discussion.

Art. 15.2.2 The Finance Committee

15.2.3.3 a) monitor the integrity of FIS's financial statements and ensure that the financial statements of FIS and its subsidiaries are prepared in accordance with the Swiss Code of Obligation (CO) International Financial Reporting Standards (IFRS) and comply with Swiss law and these Statutes, monitor any other formal announcement relating to its financial condition and review significant financial reporting judgments;

The <u>Congress approved</u> the proposal without discussion.

Art. 18.4 Amendment to the Statutes

- 18.4.1 Subject to article 18.4.2, tThese Statutes may only be amended, added to or repealed by a motion passed at a Congress meeting.
- 18.4.2 Amendments to these Statutes may be made by the Executive Board to correct typo-graphical, grammatical or clerical errors or clarification or where those amendments arise from motions to amend these Statutes, provided that the amendments do not materially contradict the decisions of Congress.

The <u>Congress approved</u> these proposals.

Art. 18.5 Effective Date

These Statutes have been adopted by the FIS Congress of 8th October 2021 and amended by the FIS Congress of 26th May 2022, and 25th May 2023 and 5th June 2024. They became effective with the amendments on 25^{th} -May 2023 5th June 2024. They supersede all prior statutes of the FIS as from 25^{th} -May 2023 5th June 2024.

The <u>Congress approved</u> these proposals.

Last Minute proposals by the FIS Council

The Council at its meeting on 4th June 2024 decided to propose to have two (2) Para Athlete Representatives in the Council.

- 10.10.3.1 Eighteen (18) of the twenty-one (21) twenty-two (22) Council Members shall be elected in one single voting round.
- 10.10.3.2 The Congress shall be required to confirm the three (3) four (4) representatives, equally from different genders, which have been elected by the Athletes Commission, according to the Rules for the Athletes Commission, by a separate vote.
- 11.1.1 The Council consists of twenty-two (22) twenty-three (23) members, namely
- 11.1.1 c) three (3) four (4) members who are athletes' representatives of the Athletes Commission, one two of which must be athletes representing Para Snowsports and confirmed by the Congress.
- 11.4.1.1 Council Members elected by the Congress act and vote as independent individuals and not as representatives of a Member Association. The three four Council members proposed by the Athletes Commissions act and vote as representatives of the athletes and in accordance with the instructions of the Athletes Commission.
- 19 Definitions Council means the supreme authority of the FIS between the Congress meetings. The Council is accountable to the Congress. It consists of the President, eighteen (18) members elected by the Congress and three (3) four (4) Athlete Representatives,one (1) two (2) of which must be the athletes representing Para Snowsports, confirmed by Congress.

The <u>Congress approved</u> these proposals without discussion.

In addition, the FIS Council also decided that two Athlete Representatives shall be in the Executive Committee whereof one must be representing Para Snowsports. In the presentation "the Treasurer" in Article 19 was stricken through as the withdrawal of proposal 8.1.7 Role of the Treasurer by the FIS Council was not taken into consideration.

- Art. 12.1 The Executive Committee consists of the President, the four (4) Vice Presidents, the Treasurer, one (1) further Council Member, one (1) two (2) Athletes Representatives in the Council, one of which must be representing Para Snowsports, and the Secretary General, who shall have no voting powers.
- Art. 19 Definitions // Executive Committee means the committee which deals with all urgent matters between Council Meetings. It consists of the President, the four Vice-Presidents, the Treasurer and and two Athlete Representative. The Secretary General participates in the meetings of the Executive Committee without the right to vote.

The presentation showed the proposal with the Treasurer as striken through. This was incorrect as the proposal by the FIS Council to dissolve the position of the Treasurer had been withdrawn by the FIS Council at its meeting on 4th July 2024. This was also mentioned before the vote on the adoption of these amendments.

The <u>Congress approved</u> these proposals.

ITEM 9 PROPOSALS BY THE MEMBER ASSOCIATIONS AND THE FIS COUNCIL RELATED TO THE RULES

Proposal 9.1 ("Competences of the Committees") was submitted to the Congress by Austria, Denmark, Finland, Germany, Norway, Switzerland and Sweden (more detailed information in particular regarding the background/reasoning, is available in the Congress Book on page 28).

The Council shall review and evaluate the structure and responsibilities of all Committees and shall make a proposal to the Congress until the next Ordinary Congress to be voted on by the Congress.

The <u>Congress approved</u> the proposal.

Proposal 9.2 ("World Cup Calendars") was brought forward to the Congress by Austria, Denmark, Finland, Germany, Norway, Switzerland and Sweden.

The National Ski Associations withdrew the proposal.

Proposal 9.3 ("Reverting the FIS Points calculation to the system used before the 2023/2024 season") was submitted to the Congress by Armenia, Iran and Lebanon

The FIS Council had decided to refer the proposal the Cross-Country Committee who decided to reject the proposal but with the adjustment of the FIS Cross-Country Point Rules with additional provisions.

A discussion on this topic took place later on and it was agreed that Secretary General Vion would have a bilateral conversation with the concerned National Ski Associations.

Proposal 9.4 was brought forward to the Congress by the FIS Council.

The FIS Council withdrew the proposal.

For the purpose of these minutes it is stated that the Congress has not been provided with International Competition Rules (ICR) for Freeride at all. Therefore, the approval by the Congress to integrate Freeride as a FIS discipline as per agenda item 8.2.2. and the corresponding statute amendment of Art. 2.2.10. is subject to the in-time approval of specific International Competition Rules (ICR) for Freeride by the FIS Council.

ITEM 10 PROPOSALS BY THE MEMBER ASSOCIATIONS NOT DIRECTLY RELATED TO THE STATUTES OR THE RULES

Proposal 10.1 ("FIS World Championships") was brought forward to the Congress by Austria, Denmark, Finland, Germany, Norway, Switzerland and Sweden.

The National Ski Associations withdrew the proposal.

Proposal 10.2 ("Deadlines to inform about sponsors") was submitted by Austria, Germany, and Switzerland.

The National Ski Associations withdrew the proposal.

Proposal 10.3 ("Cut-resistant underwear / Alpine Skiing") was brought forward to the Congress by Austria (more detailed information, in particular regarding the background/reasoning is available in the Congress Book on page 52).

The relevant FIS (Sub-) Committees (e.g. Executive Board Alpine, Committee for Competition Equipment, Legal and Safety Committee, Medical Committee etc.) and the FIS Athletes Health Unit shall discuss the implementation of a rule providing for "cut-resistant" underwear in Alpine Skiing (coming into effect as of the 2025/2026 FIS season).

The <u>Congress approved</u> the proposal.

Proposal 10.4 ("Competition suits / Alpine Skiing") was submitted to the Congress by Austria (more detailed information, in particular regarding the background/reasoning, is available in the Congress Book on page 63).

The relevant FIS (sub-)committees (e.g. Executive Board Alpine, Committee for Competition Equipment, Legal and Safety Committee, Medical Committee, etc.) and the FIS Athlete Health Unit shall evaluate whether "thicker" and/or more wind-permeable competition suits could have a safety effect for athletes and make a suggestion on how such amendment could be implemented in the relevant rules framework (taking into account a reasonable preparation time for the involved Member Associations and other stakeholders).

The <u>Congress approved</u> the proposal.

Proposal 10.5 ("Framework for ski edges / Alpine Skiing") was submitted to the Congress by Austria.

The National Ski Association withdrew the proposal.

Proposal 10.6 ("Integration of NSA experts in FIS AHU project groups") was submitted to the Congress by Austria (more detailed information, in particular regarding the background/reasoning, is available in the Congress Book on page 65).

NSA experts should be integrated into FIS Athlete Health Unit's project groups in order to improve the realization and implementation of specific processes to increase athletes' safety. Therefore, the relevant FIS (sub-)committees and the FIS Athlete Health Unit shall elaborate a structure/suggestion pursuant to which NSA experts are integrated into FIS AHU project groups.

In addition, the development strategy and the status of ongoing projects of the FIS AHU should be communicated to the Member Associations.

The <u>Congress approved</u> the proposal.

ITEM 11 THE OLYMPIC WINTER GAMES

11.1 Decision by the International Olympic Committee

President Eliasch reported in regards of the Olympic matters.

FIS is monitoring the planning schedule of the OWG 2026 in Milano-Cortina closely.

The relations with the IOC are excellent and collaboration is very good at every level. There are also discussions taking place to add new disciplines to the Olympic Winter Games 2030 and 2034.

President Eliasch has been appointed to join the Sustainability and Legacy Commission of the IOC.

11.2 Report Youth Olympic Winter Games 2024 in Gangwon (KOR)

President Eliasch thanked the organisers of Korea for a great event and fantastic organisation of the Youth Olympic Winter Games.

11.3 Report Olympic Winter Games 2026 in Milano-Cortina (ITA)

The above reports from the Organisers of the concluded and upcoming Olympic Winter Games were provided online prior to the General Assembly.

The <u>Congress acknowledged</u> the Olympic Winter Games Reports.

The evening before the General Assembly the Organisers of the 2028 FIS Ski Flying World Championships, and the 2029 FIS Snowboard, Freestyle, Freeski World Championships were elected by the FIS Council. The FIS Council furthermore decided to announce the award of the FIS Alpine Ski World Championships 2029 and 2031.

The award of the 2029 FIS Nordic World Ski Championships was postponed in July 2024 as some requirements could not be fulfilled by the appointed organiser at the time of the election. The President stated that in case these requirements will not be fulfilled, the bid process – in all likelihood – will be opened up again.

ITEM 16 REPORT ON THE ACCOUNTS, REPORT OF THE AUDITORS, VOTE ON THE ADOPTION OF THE ACCOUNTS FOR THE LAST FINANCIAL PERIOD

Stefan Ruf, Chief Financial and Administrative Officer presented for the first time consolidated financial figures for the years 2022 and 2023. He mentioned that due to some changes to comply with the Swiss Code of Obligations in Accounting, FIS recognised in 2023 the full revenue of the Olympic Winter Games 2022 which explains the main increase in revenues compared to 2022. Furthermore, he highlighted that the financial income decreased compared to 2022 because the FIS Council decided that FIS should only invest in very stable and guaranteed bonds from governments.

The <u>Congress approved</u> the accounts for the financial period 2023 without discussion.

ITEM 17 ANNUAL SUBSCRIPTIONS, CALENDAR FEES AND OTHER FINANCIAL OBLIGATIONS

The FIS Council at its meeting on 4th June 2024 approved a last-minute proposal regarding the FIS Calendar and Registration Fees that concerns amendments for Para Classification and FIS Para Nordic World Cup.

For all other subscriptions and calendar fees for the season 2024/2025 the FIS Council proposed to keep these unchanged.

The <u>Congress approved</u> the Annual Subscriptions, Calendar Fees and other financial obligations for the period 2024/2025.

ITEM 18 BUDGET FOR THE NEXT FINANCIAL PERIOD

Stefan Ruf, Chief Financial and Administrative Officer reported on the budget. He explained that the forecast for 2024 was updated with the new expected income of CHF 39,663 mio. The budget for 2025 includes the income of the FIS World Championships of approximately CHF 26 million. The other figures presented are in line with the previous years.

The Austrian delegate stated that in other International Federations the representatives of the elected external Audit Company are also present at the General Assembly to give a brief report and answer questions if they arise. He suggests that the newly elected Council takes this into consideration for the next FIS Congress.

The <u>Congress acknowledged</u> the Budget 2025.

ITEM 19 APPOINTMENT OF EXTERNAL AUDIT COMPANY

The FIS Council and its Audit Committee proposed Ernst & Young AG Bern as the external audit company for the financial period 2024.

The <u>Congress approved</u> Ernst & Young AG as the auditors for the accounts 2024.

ITEM 20 REPRESENTATIVES IN THE FIS COUNCIL AND MEMBERS OF FIS STANDING COMMITTEES

Para Athletes' Representative as FIS Council Member

The FIS Council proposed Adam Hall (NZL) as the athlete representing Para Snowsports in the Council for the period 2024 to 2027.

The <u>Congress approved</u> the appointment of Adam Hall to the Council.

Election IECO and FIS Ethics Committee Chair and members

The Council proposed the Head of Sports, Quest as Independent Ethics and Compliance Officer for the period ending 31st May 2025.

The Congress appointed the Head of Sports as IECO.

The Council proposed Michael Beloff KC (GB) as Chair of the Ethics Committee for the period ending 31st May 2027.

The <u>Congress appointed</u> Michael Beloff KC as Chair of the Ethics Committee.

Furthermore, the Council proposed Anne Christine Ramberg (SWE), Lord David Neuburger (GBR), Nicholas Zbinden (SUI) as well as Leanne O'Leary (NZL) for the period 1st June 2023 to 31st May 2027 and Ian Hunt (NZL) for the period 1st May 2024 to 31st May 2028 as members of the Ethics Committee.

The Austrian delegate mentioned, inter alia, that the diversity of nationalities of members between the Ethics Committee is not given. In addition, the question came up what the status is regarding the – since more than 20 months – still pending/open Ethic cases against some Member Associations with regard to the 2022 FIS Congress in Milano. The Member Associations have been informed by the President that those cases are under review by the responsible people who shall elaborate on that.

The majority of the <u>Congress approved</u> the above-mentioned appointments of the Chair and Members of the Ethics Committee.

ITEM 21 ELECTION OF EIGHTEEN (18) COUNCIL MEMBERS ACCORDING TO FIS STATUTES ARTICLE 10.10.3 (EXCEPT ARTICLE 10.10.3.2)

Before the election of the Council, President Johan Eliasch informed the Congress that only candidates not running for re-election would present themselves to the General Assembly.

The following Council Candidates gave a three-minute speech (in alphabetical order of their proposing NSA):

He furthermore informed that the delegates had to select 18 of the Candidates on their electronic voting ballot. In addition, the ballot needed to meet the minimum requirements as mentioned in FIS Statutes Art. 11.2 regarding the representation of gender as well as one and two-vote Member Associations. Ballots which did not contain the minimum requirements set out would be considered invalid.

As the voting procedure took unusually long, the Swiss delegate asked on whether the Member Associations would receive a LUMI report in order to be able to elaborate what might have happened in this timeframe. The President confirmed this inquiry.

Questioned by the delegate of Canada, the President confirmed that the "special dividend" based on the FIS/Infront deal will be additional to any other distributions.

In addition, the German delegate – in particular regarding the presentation given during the Congress by FIS – made a statement regarding the (potential) centralization and it was mentioned that the relevant member associations and FIS seem to be still far away from an agreement on that matter. More time will be needed to elaborate on this matter and discuss about necessary clarifications. The Austrian delegate alleged that the ICR amendment regarding the marketing and media rights already now has financial negative impacts.
